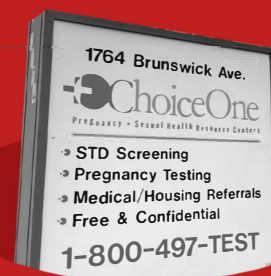
FAKE CLINICS

ANSWER: THEY ARE ALL FAKE CLINICS!

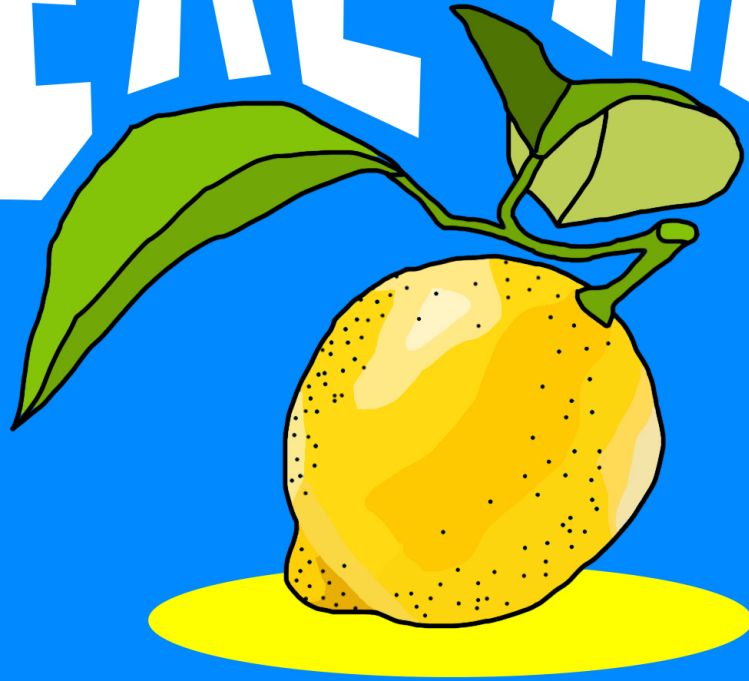

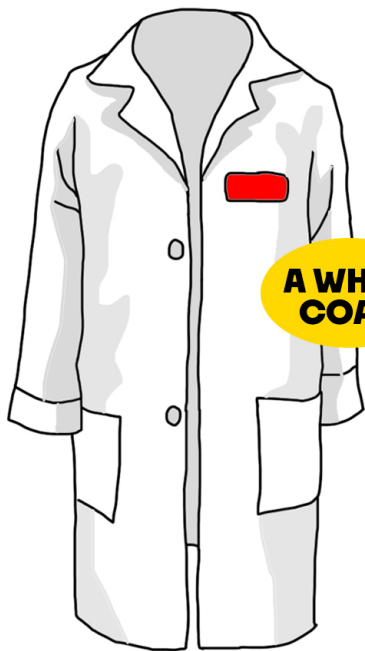

FAKE CLINICS → ARE **NOT** ← MEDICAL FACILITIES

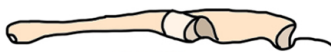

Because fake clinics are not **technically** medical facilities, they do not have no **legal obligation** to provide pregnant people with accurate information AND are **not subject to HIPAA** or required by law to maintain **client confidentiality**.

However, even though fake clinics are not medical facilities, they do everything to seem like they are - **including wearing fake white coats you can buy online and performing ultrasounds**.

At a Kentucky fake clinic, they were performing transvaginal ultrasounds and disinfecting the probes with **expired disinfectant**. This does not kill the **human papillomavirus**, a widespread and potentially deadly sexually transmitted infection responsible **for more than 90% of cervical cancer**.
